With reference to the subject and reference cited. It is bring to your consideration that the Government of Telangana vide reference 1<sup>st</sup> cited has constituted the Kalwakurthy Nagarapanchayat as Municipality. Further, the Government has also fixed the strength of elected members for (22) wards vide reference 3rd cited.

Accordingly, in the reference 3rd cited, the Commissioner & Director of Municipal Administration, Telangana, Hyderabad has issued circular instructions to take up the de-limitation of wards and submit the draft proposals for de-limitation of Kalwakurthy Municipality into (22) Wards.

6. In this connection, draft de-limitation of into ( 22 ) wards proposals have been prepared according to rules issued for division of Municipalities into Wards, Rule 1994 as amendment from time to time and rules issued in G.O.Ms.No.78 MA, Dt: 29-06-2019.

7. In this regard, delimitation proposal has been prepared, so that the population of 2011 is uniform in each ward, as far as possible while adopting the natural boundaries and geographical features in description of ward boundary and contiguity of the area The description of ward boundaries has been carried in clock wise direction starting from North, East, South and West directions. The serial numbers of wards also maintained in clock wise direction.
